If stated billing information is incorrect or in default, Screaming Broccoli Productions has the right to recover said payment from stated Photographer.
3. Renter will indemnify and hold Screaming Broccoli, INC from any claims of all persons that rental equipment is defective or not suitable for use.
4. If Screaming Broccoli, INC shall discover after the rental equipment has been returned, that same has been damaged or has parts missing, renter shall pay repairs for parts replacement costs plus rental time required for all repairs and parts replacement.
5. Renter agree not to assign or transfer this agreement or the rented property. Title to all property shall remain Screaming Broccoli, INC
